

# House Republican Alliance Recommendation Sheet

For February 23, 2005 House Session

The purpose of the House Republican Alliance is to preserve and strengthen the traditional principles and values of the Republican Party through the NH House of Representatives and throughout the state of NH, including fiscal restraint, personal freedom and responsibility, small government, free enterprise and strong families. We offer the following recommendations based on those principles, the Republican Party Platform and the NH and Federal Constitutions.



## FEBRUARY 23, 2005 REGULAR CALENDAR

### CRIMINAL JUSTICE AND PUBLIC SAFETY

**HB 46-FN**, relative to penalties for first-time DWI offenders. OUGHT TO PASS WITH AMENDMENT  
**Vote 14-2. No Recommendation**

### EDUCATION

**HB 76**, revising the process of charter school approval by the state board of education. MAJORITY: OUGHT TO PASS. MINORITY: INEXPEDIENT TO LEGISLATE. **Vote 11-8 (11R) (7D 1R)**. The platform supports education based on excellence, and further states, "Only parents can be entrusted to control the education of their children and choose schools that best suit their children's needs." If a parent chooses to send their child to a charter school, the district should have to pay for that education in a timely manner. **Recommendation- Support OTP**

### JUDICIARY.

**CACR 2**, relating to the appointment of judges. Providing that judges shall be appointed to 5-year terms of office which may be renewed. INEXPEDIENT TO LEGISLATE. **Vote 17-1**. The platform states, "Support the reasonable and periodic oversight of judicial officers, including reasonable term limitations for judges." Read the blurb and determine if this is the way to accomplish the platform intent.

**No Recommendation-Vote your conscience.**

**HB 427**, repealing common law marriage. MAJORITY: INEXPEDIENT TO LEGISLATE. MINORITY: OUGHT TO PASS. **Vote 17-5. No Recommendation**

### MUNICIPAL & COUNTY GOVERNMENT

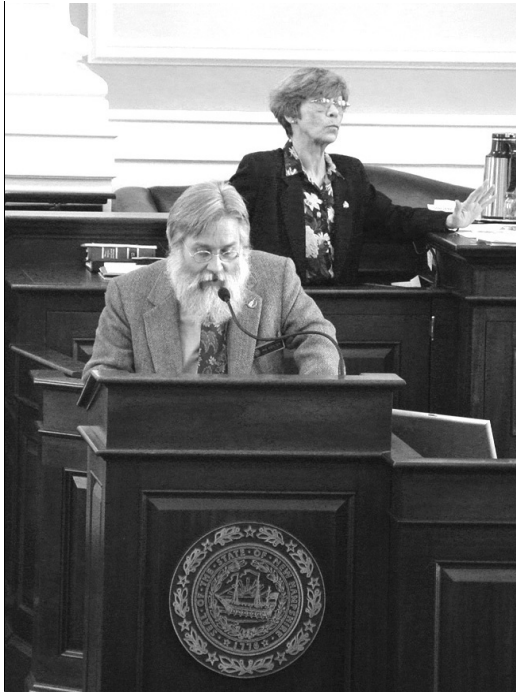
**HB 83**, repealing the obligation to provide persons applying for a marriage license with a list of family planning services and with brochures on fetal alcohol syndrome and the human immunodeficiency virus. MAJORITY: OUGHT TO PASS WITH AMENDMENT. **Vote 14-4**. All information required to be handed out by city clerks and verified received by an affidavit is readily available through other sources. Duplication of services is not efficient government. **Recommendation Support OTP with Majority Amendment.**

**HB 407-FN-L**, relative to licensing of dogs. MAJORITY: OUGHT TO PASS. MINORITY: INEXPEDIENT TO LEGISLATE. **Vote 12-4**. The law requires all dogs to be licensed. This is another attempt by those who know they have a captive audience to increase taxes on them. **Recommendation- Oppose OTP and then support ITL**

### PUBLIC WORKS & HIGHWAYS

**HB 304-FN-A**, relative to federal highway grant anticipation bonds. MAJORITY: OUGHT TO PASS. MINORITY: INEXPEDIENT TO LEGISLATE. **Vote 14-1. No Recommendation**

**HB 603-FN-A**, relative to the state's purchase of the Laconia district courthouse building and making an appropriation therefor. OUGHT TO PASS WITH AMENDMENT. **Vote 11-2. No Recommendation**
