


House Republican Alliance Recommendation Sheet

Thursday, April 6, 2023 Regular Calendar

Finance

HB2, relative to state fees, funds, revenues, and expenditures. **Maj. OTP/A; Min. ITL Vote: 14-11**

HRA Analysis: The committee amendment 2023-1247h is the bill. Bill includes a provision to move Expanded Medicaid into the budget so that actual costs are tracked and ends the program at the end of the budget cycle; but spends more than our expected revenues. Accelerates the timeline to move the I&D tax repeal from '27 to '25. Competing platform issues

HRA Recommendation: Vote Your Conscience

Finance

HB1, making appropriations for the expenses of certain departments of the state for fiscal years ending June 30, 2024 and June 30, 2025. **Maj. OTP/A; Min. ITL Vote: 14-11**

HRA Analysis: The Committee Amendment 2023-1244 is the bill.

HRA Recommendation: Support OTP/A

HB46, (New Title) establishing a committee to study replacement of bail commissioners with court magistrates. **OTP/A Vote: 21-3**

HRA Analysis: Bill creates a study committee. No platform or constitutional issues

HRA Recommendation: No Recommendation

HB74, relative to an employee's unused earned time. **Maj. ITL; Min. OTP Vote: 13-11**

HRA Analysis: HB74 attempts to redefine vacation time as wages due. By forcing one model on all New Hampshire employers, it prevents them from determining what is best for their own operations. NHGOP platform "Minimize business regulations, permits, licenses and paperwork"

HRA Recommendation: Support ITL

HB234, relative to renewable energy credits. **Maj. ITL; Min. OTP Vote: 13-12**

HRA Analysis: The bill eliminates the process of Renewable Energy Credit (REC) "sweeping" by utilities. REC sweeping allows utilities to pick-up abandoned RECs and hence reduce their pass through cost of electrical power. This saves NH ratepayers about \$3M/year. Platform: "Work to reduce energy costs..."

HRA Recommendation: Support ITL

HB250, relative to the accidental death benefit payable to a group II member. **OTP/A Vote: 25-0**

HRA Analysis: In 1967 the state retirement system set the annuity payable upon accidental death of a group II member at 50% of earnable compensation. This bill increases the amount to 100% of earnable compensation. Since the bill creates an expanded benefit with the cost being downshifted to the towns, the bill violates the NH Constitution, Part First, Art 28a.

* Possible floor amendment to correct 28-a issues

HRA Recommendation: Oppose OTP/A

HB330, relative to the national guard recruitment incentive program and its funding and rulemaking. **OTP Vote: 25-0**

HRA Analysis: Increases bonus funds to be used for recruitment. No platform issues identified.

HRA Recommendation: No Recommendation

HB337, relative to directing the office of professional licensure and certification to provide notice of public meetings and an opportunity for comment from the public. **OTP Vote: 25-0**

HRA Analysis: An administrative change; no platform or constitutional issues identified. No finance impact.

HRA Recommendation: No Recommendation

HB364, relative to transportation for students attending career and technical education centers. **OTP Vote: 25-0**

HRA Analysis: This bill authorizes the DOE to develop a formula for transportation reimbursement for students that drive to their CTE center as transportation has been limited by insufficient funding. Platform: Promote local control of education policy and funding in order to create the best managed school systems. NH Constitution tells us to cherish education.

HRA Recommendation: Support OTP

HB430, relative to applications for the education freedom accounts program. **Maj. ITL; Min. OTP Vote: 13-12**

HRA Analysis: This bill would require students to attend one year of public or public charter school before applying to the education freedom account program. Platform: "Promote education freedom and parental rights to control the education of their children."

HRA Recommendation: Support ITL

HB492, requiring the department of education to provide the house and senate standing committees responsible for education with copies of the laws and rules relative to education. **OTP Vote: 24-1**

HRA Analysis: The bill will simply require the department of education to supply education law books to House and Senate Education Committees. These are heavily relied on by members in reviewing pending legislation. No Constitution or Platform issues.

HRA Recommendation: No Recommendation

HB504, relative to the adult parole board and making an appropriation therefor. **Maj. OTP; Min. OTP/A Vote: 20-5**
HRA Analysis: Increases the pay rate from \$20,000 to \$30,000 for general members and from \$20,000 to \$40,000 for the vice chair. Platform: "government has a moral obligation to the people to be as cost effective as possible, to always limit spending and growth of government, and to cut spending and cost of government at every possible turn."
HRA Recommendation: Oppose OTP

HB534, relative to water assistance for natural disasters. **Maj. ITL; Min. OTP Vote: 13-12**
HRA Analysis: This bill provides repair or replacement of water wells in the homes of the low income should they become impacted from natural disaster. NH Constitution Violation: Part 1, Article 10 - Government being instituted for the common benefit, protection and security of the whole community and not for the private interest or emolument of any one man, family or class of men.
HRA Recommendation: Support ITL

HB576, (New Title) relative to administration of a commercial property assessed clean energy (C-PACE) program in a clean energy efficiency and clean energy district. **OTP/A Vote: 14-5**
HRA Analysis: This is enabling legislation that allow investors and private equity lenders to make loans for commercial clean energy and energy efficiency construction projects in NH to access up to 60% Federal tax incentives. More than 30 states have adopted C-PACE enabling legislation for investment in local businesses, energy, cost savings and job creation. No platform or Constitution issues
HRA Recommendation: No Recommendation

HB626, requiring the department of education to administer the education freedom account. **Maj. ITL; Min. OTP Vote: 13-12**
HRA Analysis: A non-profit organization administers the EFA. Future legislation may be forthcoming that allows for open bidding on the contract. Platform: "We believe in free people, free markets and free enterprise."
HRA Recommendation: Support ITL

Public Works and Highways

HB25, making appropriations for capital improvements. **OTP/A Vote: 17-1**
HRA Analysis: Capital improvements projects. No platform or constitutional issues found.
HRA Recommendation: No Recommendation

Ways and Means

HB639, relative to the legalization and regulation of cannabis and making appropriations therefor. **Maj. OTP/A; Min. OTP Vote: 16-4**
HRA Analysis: The bill legalizes marijuana for those 21 and older. As amended the bill now authorizes the liquor commission to regulate and administer the cultivation, manufacture and retail sale of cannabis statewide. Competing Constitution & Platform issues: Part 1, Article 18 - Penalties to be proportional to offenses. Platform issues: Minimize business regulations, permits, licenses and paperwork.
HRA Recommendation: Vote your conscience
